On the Frontlines of Mental Health Services


In collaboration with Alameda, San Francisco, Contra Costa, and Solano County, A Better Way, Inc. offers community-based mental health services using a multidisciplinary team approach.


Central to our partnership is the provision of therapeutic services and behavioral intervention for Medi-Cal eligible children, youth, and families. These individuals are either involved with or at risk of entering the child welfare system or juvenile/probation system.

Our services extend to clients ranging from birth to 21 years of age and are provided in homes, schools, and the wider community:

Specialized Areas:

Early Childhood Mental Health (ECMH): Delivered by specialized mental health clinicians, our ECMH services prioritize the well-being of young children. Our comprehensive approach supports children's mental health and simultaneously empowers caregivers with essential skills for enduring success. The goal is to transform the child's immediate environment,





School Base Behavioral Health (SBBH): Our services reach students in five schools in Alameda County and twenty-six schools in Solano County. By collaborating closely with school staff and leadership, we identify and refer students with behavioral health needs for appropriate treatment. A critical aspect of our work is fostering understanding among families about their children's behavioral health and educational requirements. Moreover, we encourage active family participation in services and treatment.



Probation Services: Through our alliance with the Solano Department of Probation and the Youth Achievement Center (YAC), we strive to offer multi-dimensional treatment and services for youth under probation supervision. The design of these services aims to diminish the probability of these youths' continued engagement with the criminal justice system, promoting positive family and community ties.



Helping Parents Navigate Systems



Parent Advocacy Programs

A Better Way has extensive experience strengthening communities through three (3) programs designed to help parents navigate or avoid the Child Welfare System. In close partnership with Alameda County, A Better Way operates two peer-led programs: the Parent Engagement Program (PEP) and Another Road to Safety (ARS), and in Santa Cruz County: the Parent Partner Program (SCPPP).

The **Parent Engagement Program** hires parents who have successfully reunified with their children after placement in the Child Welfare System. We train them to serve as Parent Advocates – mentors for parents who are currently engaged with Child Welfare System. They also serve on numerous committees and work groups and provide training and consultation on county and state levels. For many of them, this is the first job they have ever had and a pathway to greater stability.

Another Road to Safety is a Differential Response program in which we work with parents and families who are at serious risk of entering the Child Welfare System. Utilizing the Strengthening Families framework, our teams offer an array of linkages, resources, and supports to help families develop and sustain the protective capacities associated with child well-being. This program also offers Parent Cafés – informal parent gatherings to build community, share food and learn about the Protective Factors that comprise the Strengthening Families model.





Santa Cruz County Parent Partner Program works to improve outcomes for families involved with the child welfare system. Families are referred when there is a determination that resources and support are needed to stabilize the family system & ensure child safety. Parent Partners are birth parents that have successfully navigated the Child Welfare system as clients and have returned to support other parents that are involved with that system. The SCPPP also provides eligible child welfare involved parents with time-limited education, peer mentorship, and support with the goal of increasing the number of families who successfully reunify, and reunify sooner, while decreasing subsequent changes in placement or custody.

Serving as a Beacon of Hope



Permanency Programs

A Better Way, Inc, is a licensed Foster Family Agency (FFA) dedicated to the recruitment and certification of resource families through the Resource Family Approval process (RFA). A primary objective of A Better Way is to reunify children with their birth families within the foster care system. While pursuing this goal, the agency remains committed to ensuring the safety, permanency, and well-being of the children in its care.

Primary Services

The agency offers non-treatment foster care services to children who are either entering or already a part of the child welfare system through the following services:



Foster Care: A Better Way's FFA has played a pivotal role in providing foster care to countless children and families over the years with a central goal of reunification.



Adoption Services: If children cannot be reunified with their birth parents, A Better Way steps in to offer adoption services, ensuring that every child finds a loving home.




Intensive Service Foster Care (ISFC) Program: This program specifically caters to youth exhibiting challenging behavior or those with developmental needs, ensuring they receive the specialized care and attention they require.



Transitional Housing Program Plus Foster Care (THP+FC): Licensed under A Better Way, the THP+FC program is tailored for non-minor dependent youth. It offers them a stable housing environment in remote settings, either as single dwellings or with roommates, facilitating a smoother transition to adulthood and independence.






FY 2022-2023 Impact By Numbers

Client Success Stories



My client was having a hard time in kindergarten. He was in the corner body slamming other kids and not following directions whatsoever. These behaviors appeared to be the result of early childhood neglect related to caregiver struggles such as mental health issues, economic instability, and involvement with the criminal justice system.

We provided family therapy and school-based clinical consultation, and quickly began to see dramatic improvement. His caregiver and teachers have learned new ways to respond to the child's feelings and

behaviors with compassion and containment The child is now able to keep himself and his classmates safe when he becomes dysregulated. He expresses his feelings more calmly and has become more integrated into the classroom and playground culture.

He now knows that he is loveable and that he is loved. He sees his strengths reflected back to him every day. And he is thriving.


At the start of treatment, the foster mom reported being very worried and wondering if the young person needed more intensive care, perhaps residential care to help with the severity of their symptoms.

The mental health clinician from A Better Way started by building connections through various activities (skating, hiking, hot wings!). Before long, ABW's clinician and the client began the hard work of confronting the trauma and talking through the details of what happened.

They both stuck with this incredibly

difficult work and continued to build trust as the client gradually told their story.

Recently, the client said, "I can tell you anything!" Foster mom has reported that the youth is doing much better: "She has been so responsible! I'm proud of how well they are doing at home and school."






